


TOP-3 RICH persons empowered for the declaration year 2012:

- The President of Ukraine Viktor Yanukovich declared 20.388 mln UAH of income (vs. 17.362 mln UAH in 2011);
- 2) The Head of the Presidential Administration **Serhiy Lovochkin** declared 11.979 mln UAH of income (vs. 7.738 mln UAH in 2011);
- 3) The Head of Kharkiv Regional State Administration *Mykhailo Dobkin* declared 10.611 mln UAH of income (vs. 5.234 mln UAH in 2011).

Parliamentary factions financial reports-2012:

Five parliamentary factions have promulgated their financial reports for 2012.

- The most financially capable parliamentary party in Ukraine is the Party of Regions with total income – more than 325 million UAH.
- All-Ukrainian Union Batkivshchyna has taken the second place. This party has <u>114 million 494 thousand UAH</u> yearly income for 2012.
- Budget revenue of the CPU faction is 112 million UAH.
- UDAR's total income approximately <u>43 million</u>
 <u>510 thousand UAH</u>.
- The least financially capable among political parties is All-Ukrainian Union Svoboda which has spent in 2012 25 million 240 thousand UAH.
